What is **SustainabilityCheck**?

The complete sustainability assessment and verification scheme

The SustainabilityCheck Scheme has three levels; Bronze, Silver and Gold, with increasing requirements at each level.

The Scheme criteria are designed to cover the economic, social and environmental dimensions of sustainability, unlike many other schemes which only cover environmental criteria.

Below, you will find a summary of the main criteria within each level of the Scheme. A more detailed description of the criteria can be found on our website at www.loreus.com

Bronze level

Appoint a sustainability champion, create a sustainability policy, record specific sustainability metrics and set an annual target for each metric.

Silver level

Actively communicate the sustainability policy, monitor two additional, sustainability metrics, implement a recycling scheme and include a waste reduction target.

Gold level

Undertake a sustainability questionnaire with a selection of suppliers, include a sustainability disclosure in your annual report, calculate a carbon footprint for energy consumption and regularly monitor progress towards your targets.

Free registration

Registration to the SustainabilityCheck Scheme is free. Organisations only pay when submitting evidence for audit at each level.

Access to examples, audit criteria and supporting documentation

Upon registration, organisations will receive access to the full audit criteria along with examples of how the criteria can be achieved and evidenced.
